Notes for Tax Filers:

- If you amended your tax return, you are not eligible to use the IRS Data Retrieval Tool. Along with your 2015 Tax Return Transcript, you must submit a 2015 Tax Account Transcript and signed copy of your 1040X.
- If you owe the IRS, there will likely be a delay between when you file and when you may use the DRT or request your Tax Return Transcript. Please contact our office with any questions.
- If you were a victim of tax-related identity theft, you must submit a Tax Return DataBase View (TRDBV) transcript and a signed and dated statement that they you were a victim of IRS tax-related identity theft and that the IRS has been made aware of this.
