Social Function Registration Form

Only students that are 21 years old or older may be allowed to drink alcohol and they must follow the CSC Alcohol Policy as outlined in the Code of Community Responsibility.

Only rooms or apartments where one or more of the residents is twenty-one years of age or older and will be present for the event may register a social function.

This form should be used to register functions in residence halls or college houses in which alcohol will be present and which involve the following numbers of people (including residents of the room/apartment):

Single rooms: 6 people (Fire Code capacity = 6)

Doubles, triples & quads: 8 or more people (Fire Code capacity = 12 in doubles, 18 in triples, 24 in quads). **Apartments + Houses:**

Two- and three-person apartments: 8 or more people (Fire Code capacity = 18)

Four- and five-person apartments: 10 or more people (Fire Code capacity = 25)

Social functions may not be registered during Orientation, Reading Days, or Final Exam periods or during vacation closing periods.

All functions must end by the start of quiet hours.

Social Function Information

<u>Underage persons may not possess or consume alcohol anywhere on campus.</u>

The state of New Hampshire prohibits adults from purchasing alcohol for anyone under the age of 21 or furnishing it to them. An adult can face criminal charges, steep fines, and jail time and can be sued for damages caused by anyone under 21 who drank under the adults' supervision.

Residential Host Responsibilities

As Residential Hosts, you are:

- Responsible for ensuring students/guests/visitors under 21 years of age are NOT drinking
- Responsible for the actions of the students/guests/visitors
- Responsible for making sure there is a Sober Host present for the entire social function

Sober Host Responsibilities

As the Sober Host, you:

- Must be present for the entire social function
- Must abstain from using alcohol and/or other drugs for the entire duration the social function
- Are responsible for monitoring the actions of the students/guests/visitors and should intervene and/or seek help when appropriate

High Risk Drinking Behaviors: Personal Wellness & Violation of Policy

Binge drinking has tremendous consequences.

Binge drinking raises blood alcohol levels quickly, increasing side effects, including:

- Loss of critical judgement
- Impairment of perception, memory & comprehension
- Disorientation

- Mental confusion & dizziness
- Inability to stand or walk
- Vomiting or incontinence

Prohibited Alcohol: Persons may not possess or consume grain alcohol on the college's owned or leased property.

Common Sources of Alcohol: Persons of legal age may not possess any common source(s) of alcohol on college owned or leased property. Common sources are only permitted at college sponsored events where the event has received authorization from the Department of Student Activities or the college's events coordinator.

 Some examples of "common sources of alcohol" could include (but are not limited to) kegs, bars, and alcoholic punches.

Drinking practices that promote intoxication and any paraphernalia that support these are not allowed on college owned or leased property. Including (but not limited to):

- Funneling, table-top drinking "sports", and movie drinking games
- Drinking game paraphernalia could also include cards, dice, or board games in presence of alcohol.

Failure to register a social function:

Only persons of legal age may register a social function.

Social events involving or serving alcohol must be registered by at least one person of legal age, and have one designated Sober Host responsible for monitoring the behavior of guests at the event.

Violation of CSC Alcohol and Other Drug Policies as well as NH Underage Drinking Laws can result in dismissal from the school, loss of housing, and may affect scholarships and/or educational grants.
